They shall be free of any infringement on the Intellectual Property of the OEM. <p>Other Related Resources</p> <ul style="list-style-type: none">• Compatible Resources<ul style="list-style-type: none">○ The Supplier should provide Compatible Resources to Customers. Compatible Resources refer to any new toner cartridge that was manufactured by a third-party manufacturer and not by the OEM that manufactured the copier or printer. Bio-toner Resources shall be manufactured to OEM standards in quality and performance which incorporates the use of agricultural raw materials such
